

# Robert S. Keebler, CPA, MST: Understanding the Health Care Surtax

## Statutory Overview

### I. OVERVIEW OF NEW TAX EFFECTIVE JANUARY 1, 2013

- A. A new 3.8% Medicare surtax is assessed on the lesser of:
1. "Net investment income" OR
  2. The excess of "Modified Adjusted Gross Income" (MAGI) over the "threshold amount"
- B. "Net investment income" – is the sum of gross investment income over allocable investment expenses
1. "Investment income" (for purposes of the 3.8% surtax) includes:
    - a. Interest
    - b. Dividends
    - c. Capital gains
    - d. Annuities
    - e. Rents
    - f. Royalties
    - g. Passive activity income
  2. "Investment income" does not include:
    - a. Active trade and/or business income
    - b. Any of the above sources of income in "B1" above (e.g. interest, dividends, capital gains, etc.) to the extent it is derived in an active trade and/or business
    - c. Distributions from IRAs or other qualified retirement plans
    - d. Any income taken into account for self-employment tax purposes
  3. Other limitations on "investment income"
    - a. Gain on sale of an active interest in a partnership or S-corporation
      - i. Gain included as "investment income" is limited to the net gain that would be recognized if all of the partnership/S-corporation interests were at fair market value (FMV)
- C. "Modified Adjusted Gross Income" (MAGI) – is the sum of adjusted gross income (i.e. 2009 Form 1040, Line 37) plus the net foreign income exclusion amount.
- D. "Threshold amount"
1. Married taxpayers filing jointly – \$250,000
  2. Married taxpayers filing separately – \$125,000
  3. All other individual taxpayers – \$200,000
  4. Trusts and estates - \$11,950

### II. WHO DOES THE NEW TAX AFFECT?

- A.  $MAGI \leq \text{"threshold amount"}$  = No application of 3.8% Medicare tax
- B.  $\text{Excess of } MAGI > \text{"threshold amount"}$  = Application of 3.8% Medicare tax to lesser of investment income or excess over MAGI

### Married Filing Jointly Table

<sup>1</sup>The top three marginal rates in 2013 have the 3.8% surtax added to them

## Estates and Trusts

- The threshold for Trusts and Estates is \$11,950 (top tax bracket amount in 2013).
- Estates and electing trusts must select the proper year to reduce the surtax.
 

*Example: Mary dies in January 2012. Her estate elects a November 30, 2012 year end. The surtax will not apply until the year beginning December 1, 2013.*
- Distributions to beneficiaries will carry out DNI.
- Charitable remainder trusts can be used to "smooth out" income.
- Non-grantor charitable lead trusts allow an "above the line" charitable deduction – IRC § 642(c) offsetting surtax income.

## Investment Income and MAGI Strategies

### III. PLANNING CONSIDERATIONS

- A. Qualified retirement plans – reduce MAGI
1. Contributions to 401(k) plans, 403(b) plans, 457 plans, IRAs, etc.
  2. Creation of "alternative" qualified retirement plans (e.g. defined-benefit plans)
  3. Roth conversions in years where income is lower
- B. Tax-exempt/tax-deferred investments – reduce MAGI and investment income
1. Municipal bonds – remain tax exempt
    - a. Critical for trusts
    - b. 38.8% effective rate on taxable bonds
  2. Tax-deferred non-qualified annuities (during deferral period)
    - a. "Leapfrog" over high income years
    - b. Part of MAGI and investment income during distribution period
  3. Non-Qualified Deferred Compensation (NQDC)
    - a. Reduces investment income
  4. Life insurance
    - a. Modified Endowment Contract (MEC) policies
      - i. Earnings withdrawal first
      - ii. No policy loans
    - b. Non-MEC policies
      - i. Basis is withdrawn first
      - ii. Loans are not taxable
    - c. No taxable income at death
  5. Oil and gas
    - a. Immediate deduction of up to 95% of initial investment
    - b. Depletion allowances
  6. Real estate investments
    - a. Depreciation tax shield reduces income
  7. Security sales
    - a. Accelerate gains in years with low income
    - b. Collars
    - c. Merger shorts to generate capital losses
  8. Dividend income
    - a. Timing of dividends
    - b. Return of capital dividends
  9. Installment sales
    - a. Defer recognition of income over a period of time (to get under the MAGI threshold)
- C. Roth IRA conversions
1. Roth IRA distributions will not count towards MAGI
  2. Roth IRA conversion income does count towards MAGI
  3. Payment of income tax using non-qualified accounts (i.e. "outside assets") will generally result in lower future "net investment income"
  4. The "Surtax Bubble"<sup>SM</sup> is a key concern
    - a. RMDs from Traditional IRAs
      - i. Exempt from the surtax
      - ii. Increase MAGI
      - iii. Creates a 38.8% effective tax rate on IRA distributions
- D. Charitable trusts
1. Charitable remainder trusts (CRTs)
    - a. Defer recognition of income over a period of time (to get under the MAGI threshold)
    - b. Smooth out spikes in income
    - c. Exempt from the surtax
  2. Non-grantor charitable lead trusts (CLTs)
    - a. Shift income away from grantor to trust – reduce MAGI
    - b. More tax efficient under the MAGI computation formula
    - c. Charitable deduction is "above" the line
    - d. No percentage limitations on charitable deductions



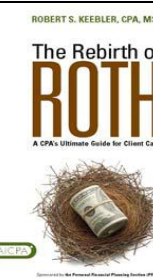
## "Surtax Bubble"<sup>SM</sup> 2013 Roth Conversions

**Converting to a Roth today will reduce MAGI tomorrow – the "Surtax Bubble"<sup>SM</sup>**

*Example: Tom and Sue age 69 have "investment income" of \$249,000. Next year they are required to begin required minimum distributions. If they take an RMD of \$100,000 their MAGI will increase to \$349,000 and \$99,000 is subject to the surtax.*

# Robert S. Keebler, CPA, MST: Understanding the Health Care Surtax

## Health Care Surtax Examples

- John, single, has \$100,000 of salary and \$50,000 of net investment income.
  - The 3.8% surtax would not apply (MAGI <\$200,000).
- Mary, single has \$225,000 of net investment income and no other income.
  - The 3.8% surtax would apply to \$25,000 of income (excess of \$225,000 MAGI over \$200,000 "threshold amount").
- Terry and Tina, married filing jointly, have \$300,000 of salaries and no other income.
  - The 3.8% surtax would not apply (no net investment income).
- Peter and Paula, married filing jointly, have \$400,000 of salaries and \$50,000 of net investment income.
  - The 3.8% surtax would apply to \$50,000 of net investment income (lesser of rule).
- Scott and Sarah, married filing jointly, have \$200,000 of salaries and \$150,000 of net investment income.
  - The 3.8% surtax would apply to \$100,000 of income (lesser of rule excess of \$350,000 MAGI over \$250,000 "threshold amount").
- Randy, a single taxpayer, age 69, has investment income of \$200,000 and is not subject to the surtax. In the following year, Randy has an RMD from his IRA of \$125,000. In this case, \$325,000 of MAGI exceeds the \$200,000 threshold and \$125,000 is subject to the 3.8% surtax.

*This is called the "surtax bubble" SM*

Surtax @ 3.8%	\$ 4,750	\$ 0
Surtax over 10 years	\$ 47,500	\$ 0

- The John Smith Trust has investment income of \$51,000 and no distributions.
  - \$39,800 of income (\$51,000 - \$11,200 top bracket amount) will be subject to the 3.8% surtax.
- David and Veronica, age 75, have pension and IRA income of \$750,000, \$25,000 of tax-exempt income and no taxable investment income. The 3.8% surtax does not apply regardless of income because they have no net investment income.
  - A Roth conversion will be surtax neutral.
- Jill, age 60, has wages and pensions of \$200,000 and interest income from CDs of \$300,000. She moves half of her investments into an annuity and purchases a life insurance policy with the remaining CDs.
  - In 2013 all of her interest is sheltered in either the annuity or the life insurance policy and she is not subject to the 3.8% surtax.
- Eliot, a widower, earns wages of \$175,000 and owns an interest in a publicly traded real estate partnership which generates taxable income of \$50,000.
  - \$25,000 (excess of \$225,000 MAGI over \$200,000 "threshold amount") will be subject to 3.8% surtax.

- Larry, a widower, earns wages of \$175,000 and owns an interest in a closely-held real estate partnership which generates taxable income of \$75,000.
  - His MAGI is \$250,000 and \$50,000 will be subject to the surtax (lesser of rule).
- Bruno, a single person, earns wages of \$200,000 and receives royalties of \$60,000 from an oil and gas limited partnership.
  - \$60,000 will be subject to the surtax (excess of \$260,000 MAGI over \$200,000 "threshold amount").
- Mary and David earn wages of \$260,000 and receive a trust distribution of \$90,000 (100% dividends).
  - \$90,000 (net investment income) will be subject to the 3.8% surtax.
- The estate of Jane Smith earned \$111,200 of dividends and made no distributions.
  - Assuming a threshold exemption of \$11,950, \$100,000 will be subject to the 3.8% surtax.
- The estate of Jane Smith earned \$111,200 of interest and made a distribution of 100% of income.
  - The income will be reported by the heirs and the estate will not be subject to the 3.8% surtax.
- Bob and Bonnie have interest income of \$248,000 and no other income. They convert Bob's \$300,000 IRA to a Roth IRA which increases AGI to \$548,000.
  - Under the lesser of rule, \$248,000 will be subject to the 3.8% surtax; this is the lesser of \$298,000 of excess MAGI (\$548,000 - \$250,000) or \$248,000 of investment income.
- Randy converts a \$1,000,000 IRA to a Roth IRA incurring \$450,000 of state and federal income tax. Randy pays the income taxes from his outside/taxable investment funds.
  - Future investment income from the outside funds will no longer exist and avoid the 3.8% surtax.
- Daniel and Donna have wages of \$250,000 and investment income of \$45,000. Their employer creates a new deferred compensation plan allowing a contribution of up to 20% of income (i.e. \$50,000).

Surtax @ 3.8%	\$ 1,710	\$ 0
Surtax over 10 years	\$ 17,100	\$ 0
Surtax Savings		\$ 17,100

- Gary and Barb, age 69, have pension income of \$130,000 and investment income of \$115,000 for a total MAGI of \$245,000, just below the threshold amount. In 2013, their Roth IRA withdrawal will be \$50,000.
  - No 3.8% surtax will apply because the \$50,000 Roth IRA distribution does not count towards MAGI.
- Thor and Kristen, age 69, have pension income of \$100,000 and net investment income of \$75,000 for a total MAGI of \$175,000, well below the \$250,000 threshold amount.
  - In 2013, their RMDs will be \$50,000 bringing MAGI to \$225,000, which is still below the threshold amount.
- Art and Patricia, age 69, have pension income of \$130,000 and net investment income of \$115,000 for a total MAGI of \$245,000, just below the threshold amount. In 2013, their RMDs from their IRAs will be \$50,000, which brings their MAGI to \$295,000.
  - MAGI is \$45,000 above the threshold amount (\$295,000 less \$250,000).
  - The surtax will be imposed on the lesser of \$45,000 or their net investment income of \$115,000. (i.e., \$45,000).
- Same facts, except they convert in 2013 and the pension is \$30,000. The conversion would be added to MAGI of \$195,000 and their entire net investment income of \$115,000 will be subject to the surtax.

- Brian and Betty, age 69, have annual pension income of \$260,000 and net investment income of \$115,000 for a total gross income and MAGI of \$375,000. In 2013, their RMDs from IRAs will be \$50,000 bringing MAGI to \$425,000.
  - Because their "fixed" non-investment income of \$260,000 (e.g. pensions) is over the \$250,000 threshold amount, their surtax reduction planning must focus on reducing net investment income, not on reducing MAGI.
