- Maintained a 3.0 GPA or higher
- Actively involved in campus and/or community activities
- An ethnic minority (Black or African American; Hispanic or Latino; Asian; American Indian or Alaska Native; Native Hawaiian or Pacific Islander; or of two or more races)
- A U.S. citizen or permanent resident (green card holder)
- Have not attended a past workshop

Individuals who are already CPAs are not eligible to attend as participants.
